- Word limit for extended abstracts is 1000.
- It should include the purpose of research, brief literature review, methodology, data analysis and conclusion.
- Each extended abstract should have at least 3-4 keywords.
- All abstracts will be blind peer reviewed by a panel of experts.
- In a joint submission at least one of the authors should register and be present for the Conference.
- All accepted abstracts will be published in a compendium with an ISBN.
- Font used should be Times New Roman, 12 font size and single spaced.
The document must be in Word Doc format only.
